NOAA asked us to tag 2000+ sharks I believed that total was surpassed.

The winner of the Mitchel Hedges for last season was Mark Jones from North Devon with a Porbeagle of 88 inches. The best Blue of the season was caught by Dave Gorring. This year like last year the Blues were here early and the committee has already started receiving trophy claims.

There will be voting a little bit later for places on the committee. I ask if you are voted on that, you attend the meetings in person or join us via zoom. It always helps to get different opinions on different issues that arise over the year, as well as new ideas. I wish you all the best of luck in the festival and for the rest of
